The respective departments note their Departments time table and distribute among the staff members. The heads of the department convene meetings to distribute the syllabus among them. Findings of the Feedback about the Curriculum from the teachers:

- The above graph indicates, most of them have the opinion that the present curriculum has the capacity to support students in their learning and is career oriented

The feedback from the students regarding the syllabus is collected at two stages. stage, the teacher after giving a bird's eye view of the curriculum, briefly explains the contents in the syllabus, ensures the significance of the content, relevance, modern implication employability, availability to resources which enables the stakeholders to form a positive in their mindsets. The teacher traces the teach-ability and feasibility of the syllabus. The students then expresses their views about the curriculum.

At the second stage, the head of the department collects the feedback from the students. In the process of collecting feedback, collective opinions are prioritized. The concern Head of the Departments emphasized the importance of the pedagogical perspective in disseminating curriculum, based on the feedback given by the students. The Institution tries to communicate with concerned university authorities with recommendations.
